BRAKES DISHWASHER POWDER



A soluble free flowing chlorinated dish wash powder developed for small single tank and domestic dishwashers. It is both economical and effective, specifically formulated to remove stubborn food deposits from all wash ware and to leave crockery and cutlery sparkling clean.

HOW TO USE

Highly effective dishwasher powder for use in smaller commercial dishwashers/glass washers. Designed to remove the heaviest organic soils from crockery, cutlery and glassware. For optimum results, ensure your dishwasher wash temperature is above 50°C.

Single Tank Machines:

Add 1 scoop of powder (1 scoop = 50g) for every 5lts of wash water, directly into the wash tank and wash items as normal. After every 6-8 washes add 1 more scoop of powder to the wash tank water.

Domestic Machines:

Using the scoop provided, add 1 scoop of powder to the powder hopper for each wash.

Caution:

Certain items are not suitable for cleaning in automatic dishwashers – these include some lead crystal glasses and decorated glassware, antique and hand painted porcelain, coloured and anodised aluminium, items with gold or other precious metal decorations, some unglazed items or where the decoration is on top of the glaze.

If in doubt, consult manufacturer's recommendations or test wash on one item first.

It is recommended that a tub of Brakes Dishwasher Powder be kept on every site, even when an automated dosing system is in use. Should the automated dosing system fail, the powder can be manually dosed allowing the dishwasher to remain in service.

SAFETY ADVICE
