HOW TO USE

Brakes Urine Neutraliser is used directly from the bottle as a ready to go solution and requires no dilution with water.

- A fast action surface urine neutraliser containing a long lasting residual fragrance specifically designed to encapsulate and destroy foul smells from the surrounding air/soft furnishings.
- It contains an encapsulating complex whereby mal-odour molecules are bound together to freshen stale/stagnant enclosed air spaces and surface contamination. Treats urine smells in residential care homes, toilets, nappy bins, washrooms and areas where stale urine/faecal mal-odours may be prevalent.
- Using the trigger bottle atomiser, spray directly onto the contaminated hard floor/surface or carpet area. If on carpet, blot up with a clean sponge, mop or paper towel and allow to air dry.
- Where there is heavy urine contamination, clean first with a carpet shampoo via a hot water extraction machine.
- Caution: Pre-test material in an unobtrusive area for colour fastness.
